Holly asked Chuck to go over the Autocross and Treasurer's Reports.

Holly said that the March autocross was a success. It was fun even though we could only fit 7 runs. Also, Holly indicated that according to Clay the registrations were full for the April 17th upcoming autocross with some people on the waiting list. Holly said that we will need to find out who is going to be helping on the Friday before. Gale asked if they had enough help the last time. Holly said yes, the usual. Holly added that they had a couple of people out there blowing the track and then she added that there was barely enough but got it done.

Jeff indicated that he is looking for a sweeper that you can tow behind a truck and has a hopper on it. We could use a blower to catch what was missed. Jeff said that he talked to a guy that knows where we can rent one. Jeff is going to follow up on that.

Gale asked if she should be calling Clint. The answer from Chuck was yes.

There was some discussion about the confusion with a couple of multi-driver cars and their car numbers in the March autocross. To this effect, it was pointed out that the Tech folks should be looking to make sure that the numbers are appropriate and correct.

New/Old business- Holly Palmer for Clay Beck

Gale proceeded to share that after very careful and thorough consideration of rates and dates she is proposing that we wait until next year to have another annual event. The rates for the hotel have skyrocketed from the year before. She checked on several alternate dates for rates but none of them seem reasonable.

There was some discussion about the annual event not being a money maker and that a weekday event would not be a smart option. Gale shared that this event requires long term planning. As well, as the fact that we no longer have some of the members that were key in helping put it together.

It was unanimously agreed to cancel the annual event for this year.

Treasurer's Report- Chuck Robertson

Chuck had previously emailed the Autocross and Treasurer's report to the club membership prior to the meeting. He went over the March 13, 2021 autocross report first. The total income for the autocross was \$3,265.75 in registrations and \$10.00 on car number sales. Apparently, there is one registration that has not been paid. The expenses were \$1,489.30 of which \$252.63 was for the portable johns, \$6.67 for Ice, \$550.00 for the use of the airport track, \$500 for the Allan Hancock Foundation Scholarship and \$180.00 for the NCCC fees. This resulted in a profit of \$1,786.45.

Chuck indicated that we started the month of March with \$4,676.03 in the bank. Under income, we received \$3,275.75 from the March autocross. Under expenses, the report shows \$809.30 for the autocross. This was further broken down into \$252.63 for the portable johns, \$6.67 for ice and \$550.00 for the use of the airport track. Also, \$45.00 for renewal of TSA badges and \$10 for the renewal of the club trailer's tags. At the end of March, we had \$7,087.48 in the bank.

We couldn't approve these reports due to lack of quorum.

VP Report— Holly Palmer

Holly chaired this meeting.

Autocross Event Details



Autocross Event Details Saturday, June 26, 2021

These events are sanctioned by the National Council of Corvette Clubs, Inc. (NCCC). Autocross classifications are as outlined in NCCC guideline. For members of NCCC, the sanction numbers are WC-518-005 and WC-518-006. Non-NCCC members and all makes of cars and trucks are welcome to participate. All non-NCCC member participants will be placed in one of the following four groups. A and B Men's and A and B Women's. Open A are vehicles that utilize Uniform Tire Quality Grade (UTQG) treadwear rating 200 or less. Open B is rating 201 or greater. Non-NCCC Corvettes the meet the safety and classification requirement of a NCCC class may participate in that class for trophies but they will not be awarded points, nor affect member's points.

Registration is accepted online only at <u>motorsportreg.com</u>. There will be no registration the day of the event. If two participants are driving the same car, both must register as separate drivers. Participants must be 18 years old. Registrants will receive an email registration confirmation with car number. Please be sure your email address is correct on your online registration.

SNELL approved "SA" or "M" helmets less than 10 years old are required. Drivers must wear securely fitting shoes with closed toes. Entrants will be divided into groups for both the morning and afternoon events. Unless physically unable, all participants will be asked to volunteer as course safety workers.

Santa Maria Airport is a TSA controlled facility with strictly enforced security. Vapor Trail Vettes must conduct this event accordingly. Participants must enter and leave via one secure gate monitored by a TSA guard. The gate will open at 6:30 am and will be closed at 8:00 am and unmanned until the event's conclusion. We strongly urge you to arrive no later than 8:00 am. No one will be allowed to enter after 8:00 am. All participants must sign an event waiver and workers will be issued a wrist band that must be worn at all times within the TSA boundaries. Drivers will be issued a wrist band when checking in at the autocross trailer. Once you enter the TSA controlled zone, you must leave through the secured gate only once. One entry and one exit only. Ensure you have everything you need for the day including enough fuel for all runs. All entrants must be a driver or a volunteer event worker. Sorry, TSA regulations do not allow this to be a spectator event.
