#### October 5, 2023 VTV Meetings Minutes

The VTV meeting for the month of October was held on Thursday, October 5th, 2023, at the IHOP in Santa Maria. There were 9 attendees present. The attendees were: Gerry White, Brenda Parks, Bruce Potter, Hector Paz, Gale Haugen, Larry Wright, Chuck Robertson, Clint Perry, and Mark Farbaugh. Gale sitting in for Clay called the meeting to order at 6:30 pm.

Gale started the meeting by announcing the October birthdays. Hector Paz on the 1st. Happy Birthday Hector!!!!

#### **Meeting Minutes Approval**

The next item was to approve the minutes from the September 7th meeting. Hector made the motion and Chuck seconded. All were in favor and the motion was approved.

#### Old Business-Gale for Clay Beck

The first item under Old Business was the Lessons Learned from the Annual Blast. Gale started out by saying that she was hoping to get input from everyone about what went well and what items we need to improve on. She shared some ideas of things that went well:

- 1. Hosting in a larger room was so much nicer.
- 2. Ordering snacks from the hotel in lieu of everyone having to cook and bring food in.
- 3. No host bar helped in keeping the cost down.

Things that we need to improve on were:

- 1. Extend the time for the morning activities.

  There were too many activities going on at the same time.
- 2. Cut the miles down on the gimmick rally from roughly eighty (80) miles to somewhere between fifty (50) and sixty (60) miles. Although most of the people enjoyed the scenic parts of the route.
- 3. Volunteers for the poker stops. She suggests that next year members volunteering for these positions should go and check out their location prior to the event.

The second item under Old Business was support for the National Corvair Club in 2025. This item was brought up by Clay in the September meeting. Gale added that in addition to requesting support to host an autocross they are asking for information in hosting a poker rallye. A few of our past rallye routes were provided to them.

#### **New Business— Gale for Clay Beck**

- 1. Larry talked about the upcoming 2024 VTV Executive Board members election. Larry reported that he is preparing an email that will be sent out to all the members asking for nomination(s) for President, Vice President, Treasurer, NCCC Governor and Secretary. Also, he asked whoever is considering nominating someone to make sure they have the consent of the member. Also, he added that at the November meeting he would present the list of nominees and a vote will be taken to announce the new board members. Other non -voting positions (i.e., Sunshine person, Newsletter editor and Webmaster) will be appointed by the new Board. At this point Brian Phillips asked what positions were open and what their duties were. Larry gave a brief description of their duties and responsibilities. These descriptions can also be found on the website under By Laws.
- The next item for discussion was membership renewals. Gale said that these are due by November 15<sup>th</sup>. All dues paid after that date will be charged an extra ten dollars.
- 3. The last item was the NCCC awards for 2022. Awards were presented (posthumously) a 1<sup>st</sup> place award to Jeff Palmer for total overall points and Bee Jay Jones for most autocross points. Men's most worker points went to Gerry White and Hector Paz. The last award went to our club for having the most points in the West Coast Region.

#### Treasurer's Report- Chuck Robertson

Chuck went over the income and expenses by individual item for the Blast. There was \$6,655 in Income and \$6,269.18 in Expenses resulting in a Net Income of \$385.82.

Next Chuck went over the September income and expenses. September started out with \$16,258.87 in the bank. Under September income, we had \$3,016 for Blast registrations and \$25 for the 50/50. The expenses were \$6,618.45 of which \$511.20 was for the website and \$6,107.25 for the Blast. At the end of September, we ended up with \$12,681.42 in the bank.

Next was the Proposed Budget for 2024.

#### **Treasurer's Report- Chuck Robertson**

Under Income was \$500 for Home Motors sponsorship, \$6,500 for the Blast, \$12,500 for 4 (four) autocrosses, \$800 for NCCC membership dues, and \$200 for miscellaneous items for a Total Income of \$20,500. Under Expenses there was \$50 for postage, newsletter printing and mailing etc., \$200 for P.O. Box rental, \$150 for our website, \$2,000 for four (4) \$500 scholarships to the Allan Hancock College Foundation, \$1,000 for the Christmas dinner, \$6,300 for the Annual Blast, \$200 for badges' etc., \$800 for NCCC dues, \$35 for Regional dues, \$50 for the Sunshine person, \$7,000 for four (4) autocrosses, \$100 for Security badges, \$3,300 for donations, \$750 for three (3) NCCC West Coast Regional meetings, and \$1,000 for miscellaneous expenses for Total Expenses of \$22,935 leaving a Proposed Net Loss of \$2435.00. Chuck added that he would be emailing a copy of this proposed budget to all the club members to get their input and would be ready to present a final proposed budget in the November meeting.

Gale asked for approval of the Treasurer's Reports. Gale made a motion to approve the Treasurer's reports, and Larry seconded it. All were in favor and the motion was approved.

Next Chuck discussed the proposed donations for this year. He explained that last year we gave a check for \$600 to the Santa Maria Food Bank. Some folks discussed making a photo op of the donation. More discussion to follow at the November meeting.

#### **VP Report- Gale Haugen**

Gale reminded everyone about Brian Phillips' proposal to go on a run to the Mullin Auto Museum in Oxnard on October 28<sup>th</sup>. It requires the purchase of tickets online. We are going to meet at the Chevron station at 9:00 am on the corner of Bradley and Santa Maria Way. Brian explained that it is a 2 (two) hours' drive from Santa Maria and maybe stop halfway at the IHOP in Carpinteria on Casitas Pass Road for breakfast. That would leave a 50-minute drive from there.

#### Governor's Report - Gale Haugen

Gale shared some of the highlights from the NCCC West Coast Governor's meeting that was held in the Santa Maria Inn on the Saturday of the Blast.

- 1. NCCC wants every club to achieve a minimum of 51% (fifty-one) NCCC primary members and 49% (forty-nine) enthusiasts and others.
- Voted all EVs will not be allowed at any West Coast Regional events with the exception of Hybrid EVs
- Voting on Competition changes will now be opened to the clubs for discussion prior to voting.

**Brian** was excited about the trip to the Mullin Museum. **Bruce** shared that he has a friend who lives in Atascadero and has a ranch that we might consider driving up to visit. **Larry** thanked everybody for their contributions to the success of the Blast. **Chuck** also thanked everyone for a successful Blast. **Clint** shared that his dad tripped over a dog and broke his hip.

## Tech Corner—Questions Asked About Corvettes

#### How much will the 2023 Z06 cost?

\$106,395

The new Z06 is nearly \$25,000 more than the old one, and a loaded model approaches \$160,000 with options including the \$8995 Z07 package and \$11,995 carbon-fiber wheels. Chevy has revealed pricing for the 2023 Corvette Z06. It starts at \$106,395 for the base 1LZ, and the convertible is \$7000-\$7500 extra.

#### What is considered the poor man's Corvette?

#### What color Corvette is best for resale?

Among these transactions, the study found that the median premium for each major color group indicated white as the most valuable Corvette color, followed by yellow, purple and red. On the other hand, colors like brown, green, copper and bronze had the least resale value. Sep 29, 2023

We recommend staying away from the 2005, 2006, 2007, 2009, and 2013 models. These may require pricey fixes, especially since the car is one of the rarer choices. The biggest fault in these models of the C6 Corvette is in the transmission.
